Giving New Hampshire's Abused Children a Voice in Court

MANCHESTER – Court Appointed Special Advocates (CASA) of NH has five trainings planned for the rest of 2008. We are in need of men and women who will advocate for the best interests of abused and neglected children in NH courts. Currently, CASA is able to accept 70% of the cases we are offered. We want to be able to provide EVERY abused and neglected child in our state a voice in court - will you be that voice??

Being a CASA volunteer isn't for everyone. We ask our volunteers to stay on a case until it closes, which averages two years, and to visit with the child or children on their case at least monthly. Volunteers must be available for scheduled court hearings; there are five to six during the first year. On average, our volunteers spend 15 hours a month between visits, court, follow-up and report writing. Our volunteers work with families, social workers, attorneys and judges to ensure a

safe and permanent home for these children. After a careful screening and application process, volunteers receive 40 hours of specialized

Dover training takes place be-tween October 27 and November 15. It is an evening/weekend schedule. Manchester will be a daytime training, taking place between November 5 and 14. Sugar Hill (October 25 through November 15), Keene (November 1 through 22) and North Conway (November 8 through December 13) will all be independent studies.

Vandals Cost SHARE Precious Funds

MILFORD - The new SHARE building, formerly owned by the Knights of Columbus was vandalized on Friday and Saturday nights, September 26 and 27. On Friday the vandals broke into the building and sprayed the contents of a fire extingusher around, got into the cupboards and broke some dishes on the floor and broke a two-way window located inside the building. They also took drinks and food that was there for the volunteers who had worked all Friday afternoon do-

ing demolition work.

We were very sad to see what had happened during the night Friday and we took precautions to try to make sure it didn't happen again by securing the door they had used to enter the building," said Carolyn Momenee, co-director of SHARE.

On Saturday night they were not able to enter the building but they did damage from the outside-breaking windows in two doors trying to enter and also a window in the

"On Friday volunteers came and worked hard getting the rooms ready for the "extreme makeover" and it is disheartening to see that parts of the building that were going to be used are now damaged," said Momenee.

SHARE faces replacing windows and doors. Momenee wrote in an email, "These are expenses we had not anticipated. Also, it appears we will have to put in a good security alarm system to ensure things like this do not happen in the future."

She continued, "We do forgive the vandals who are doing this and hope that they realize that they are damaging a building that is going to used to help people in the community. We hope they will turn their energy and time into good and volunteer their services to build not destroy. This truly is a wonderful caring community and I know we can and will all work together to make the SHARE Center a safe place where people can come for help."
