# 1,008 New Bills in Legislature

Christmas is the season for gift giving, and your legislature in Concord will be offering you gifts of 1,008 new bills.

Yes, there are this many new bills being introduced in January. Some of you may consider the bills as gifts of diamonds, others, as lumps of coal. ou decide.

The following are a sample of the bills with the identifying bill number. All 1,008 bills can be reviewed on the state web site for 2009 bills::

Income Tax, three bills, (22, 23, 404) Same Sex Marriage, (8) Surcharge on Court Fees, (28) Gasoline Tax Increase, (94, 537) Medical Marijuana, 43 Increased Road Tolls, (407) Inventory and Use Tax, (486) Estate Tax, (487) Physician Assisted Suicide, (408)

The approximate cost to process each bill through the legislature is \$3,000; a whopping \$3,024,000 for the 1,008 bills.
