# **Death Penalty Problems**

#### To the editor:

Recently I read that a local legislator proposed expanding the NH death penalty to include crimes such as the Cates murder in Mont Vernon. Within hours of reading that, I heard of a current US Supreme Court case involving two men who were wrongly jailed for 25 years of life sentences for a murder they did not commit.

The justice system is not perfect. For high-profile crimes it may be especially imperfect because of the intense public pressure on prosecutors and police to get convictions. Prosecutors, police, judges and juries are human and, like the rest of us, are endowed with their share of weaknesses and imperfections. At least with a sentence of life in prison there is a chance that wrong convictions can be remedied.

One argument offered in favor of the death penalty is the deterrence factor. However, I have seen no evidence that the alleged perpetrators of the Mont Vernon breakin and killing were thinking much, if at all, about con-

As a widow and single parent whose husband died from the senseless actions of others, my heart goes out to David and Jaimie Cates, their family, their friends and their Mont Vernon community. Through my lens at Souhegan High School, I see a school community united in their healing. I see a passionate staff united in hope for the future of our students. I am proud to have joined this special group of educators.
