David was a member of several of the original organizing committees for Souhegan High School, both his children were educated in the Amherst and Souhegan systems, and he has served as a member of the Souhegan Advisory Finance Committee for the past several years. The hot topic in the Souhegan School District this year seems to be the high cost per pupil at Souhegan relative to other school districts in the surrounding area, as well as compared with other schools in a Board selected "peer group" in the State of New Hampshire. At \$19,000 per pupil, Souhegan ranks the highest among our neighboring districts and the peer group. Indeed, the current Souhegan Board has taken great pains this budget season, through several letters to the editor and comments made at both the Deliberative Session and the Public Hearing, in acknowledging that the cost per pupil is too high and assuring us that they are aware of it and "are working on it." Although I very much want to believe them, several things cause me to give pause. Firstly, at the Deliberative Session, the Board began their comments by stating that they acknowledge that the cost per pupil is too high, but then spent considerable time during their presentation in trying to convince us that it really isn't that high. Later, several board and community members commented that if the cost per pupil is high, it is worth it because excellence comes with a cost. I left the meeting scratching my head and wondering if the Board really thinks the cost per pupil is too high, or not? Secondly, the current Board seems to be particularly upset that the high cost per pupil issue, and a plan to address it, is the centerpiece of David Chen's candidacy. If the Board really thinks that the cost per pupil is too high and "are working on it", why would they be opposed to someone who shares that view and has put forth a plan to address it?

Unfortunately the answer to that question is one of the ugly truths about the Souhegan Cooperative District. In the interest of full disclosure, I have lived in Amherst for 27 years, and my children were born here. I have been an enthusiastic cheerleader for our town and schools, delighting in the fact that my children have had the opportunity to live and be educated in such a passionate and caring community. But it is my observation that there has been a certain level of passion about the Souhegan District since inception that has stifled open and honest dialogue about spending priorities and budgets. Any critics of the budget process are immediately demonized and branded as enemies of children, education, and the school. That has happened again this year and it is unfortunate, for our school system faces the very real task of aligning an ever increasing budget with a declining student population, while still providing and preserving a quality education at a reasonable cost to the taxpayers. New and innovative thinking should be welcomed and encouraged and legitimate concerns about the cost of education should not be immediately labelled dangerous and subversive.

I have known David Chen for almost twenty-five years, and I know that his commitment to the children of this community and to the excellence of our schools runs very deep. I admire his courage in tackling the very thorny issue of aligning costs with declining enrollment, while still committing to providing a quality education for all our students. Please join me in voting for David Chen at the polls on March 10th, 2015.

Dave Chen Can Address Two Key **Issues**

The SAU has made some progress in maintaining or slightly reducing the cost per student, but it takes a long term commitment to make some structural changes in the cost of operations to bring them down to a level comparable to our peers. The second issue is the need to add to the Common Core State Standards CCSS) curriculum so that our students will still be able to gain admission to and graduate from selective colleges and STEM programs in all colleges. This is a critical issue that most people and even educators do not seem to be aware of or addressing. When the CCSS were designed there was supposed to be a third pathway for students who wanted to go to a competitive college rather than a community or non-selective college. This third pathway was also to allow students going to college to get into science, technology, engineering, mathematics (STEM) as well as finance and biology which require a more rigorous preparation in mathematics. This third pathway also called the pre-calculus track was never developed. It is now up to our SAU to develop a curriculum that fills in this void for students who want to excel in the sciences. Dave Chen is committed to looking at how we can take advantage of new developments in learning styles and the application of technology. Let's invest wisely in our educational assets so that they continue to graduate outstanding students.

The job of Cemetery Trustee is surprisingly complex.

It follows that a prospective Cemetery Trustee benefits from having a detailed knowledge of how the Town operates, from having had service on previous Town Boards or Commissions, from having constructed budgets under NH Revised statutes Annotated (RSAs) and who has been careful in the expenditure of tax payers' money. Being a Cemetery Trustee is more than administration. It also means helping families and being sensitive to their needs at a time of interment. Investing in Early Education Offers Long Term Returns

To the editor:

It's an estimated 39 cents per thousand or \$128.70 on a \$330,000 home. That's the bottom line cost for providing a full day kindergarten program in Amherst, but there is much more to the story

94 plus districts in New Hampshire offer full day kindergarten for all

The percentage of students enrolled in full day Kindergarten programs nationally is currently at 82%

In the state of New Hampshire, approximately 70% of children have both

The majority of this nation's 5 years olds already have a full day Kinder-

The new College and Career Ready standards (that we are now operating under) are based on a full day Kindergarten program. Our Kindergarten students and teachers are trying to meet these standards in a three hour

day. Our neighbors in Mont Vernon recognize this and will be implementing $f_{n+1} = f_{n+1}$ a full day Kindergarten program this fall.

We believe we need to offer full-day for ALL students in order to ensure equity and access to ALL programming for ALL students.

After speaking with local realtors, we understand that home values could be positively impacted by the implementation of a full day program.

Today's kindergarten experience is vastly different from even 5 years ago. It is a much more rigorous, academic program which leaves little or no time for two other very important pieces of early childhood education, namely, building the social/emotional skills necessary for each student's future success, and incorporating play or music/arts into their day. was presented with extensive data facts and re-

The Amherst Board search about Full Day Kindergarten. We found the material to be compelling and difficult to ignore, and the Board made the decision to present the proposal to the town.

A public forum video on full day Kindergarten is available for viewing on our sau39.org website.

As a Board, we encourage voters to ask questions of our administrators, review the information that has been provided on the school and SAU #39 websites, and to make an informed decision based on the facts and information available. The Amherst School Board believes that we have an obligation to pro-

vide our children with the best educational experience possible and that 39 cents per thousand is a responsible investment. We are asking the voters of Amherst to support this article on March 10.
