Addressing Cost Per Pupil Misconceptions

To the editor:

In the last issue of *The Amherst Citizen*, I explained the Cost per Pupil (CPP) calculation in detail. CPP is the NH Department of Education's (NH DOE) standardized metric used to compare the day-to-day operating expenses of schools. I would now like to address some of the misconceptions surrounding the usage of CPP as a comparative tool. Below are some of the

comments made at previous school meetings:

COMMENT #1: "CPP is an Apples to Oranges Comparison, so it cannot be used to compare school districts.'

False – CPP is comparable across school districts, because all schools are capturing the same data on the state's end of year fiscal report, Form DOE-25. The NH DOE then extracts the operational costs of each district by removing exactly the same elements from each district. Distortions are eliminated, thus ensuring comparisons are valid on a community-wide basis.

COMMENT #2: "CPP cannot be compared when grade ranges differ." *Possible with Adjustments –* The information captured on the DOE-25 is broken down into appropriate school level comparisons by the districts reporting (Elem, Middle/Jr or High School). The high school column on the NH DOE report is directly comparable to other districts, because all high schools in the state include four identical grades 9 to 12.

Although the grade ranges for Elementary and Middle schools may not always be identical, CPP reported to the NH DOE by school level are generally comparable, because the costs are captured by the school district at each level and the denominator used for the number of students is based on the actual grade ranges included. A calculation with adjustments can be made to compare the exact same grade ranges using a weighted average approach. However, this second method is more complicated and the total cost value calculated by this method does not differ significantly from the NH DOE reported CPP. Consequently, the use of the NH DOE CPP standard metric for school level cost comparisons by district is both efficient and reasonable for general cost trends, even when grade ranges in the respective school districts are not exactly the same.

COMMENT #3: "Costs cannot be compared when allocation formulas used to allocate district-wide costs vary."

Somewhat true, but minimal effect overall - In a unified district, shared costs are allocated to particular levels of the district – Elementary, Middle/ JR and High School. Allocation methods may vary slightly from district

to district, but 100% of the actual costs must be included on the community-wide DOE-25 reports. Therefore, the cost comparisons for all school levels in a community, K through 12, are accurate and valid even if there is a slight under or over allocation to a particular school level. Business/Finance Managers in the various communities try to capture direct costs at each respective school level and then allocate the remaining costs using a logical methodology.

The "NH Financial Accounting Handbook For Local Education Agencies" found on the NH DOE website gives some common examples of logical ways to allocate costs. Therefore, any variance due to the allocation method used should be minimal. Large CPP variances between communities cannot be justified solely by the cost allocation method used.

COMMENT #4: "CPP is not the total cost to educate our students."

True – CPP is intended to capture only the day-to-day operating costs. The costs removed in the CPP calculation outlined in the last Amherst Citizen issue (transportation, cost to send students to other schools, capital Items and summer school) need to be added back to determine our actual annual costs. In addition, all warrant article expenses need to be added in to calculate an overall Total Actual Per Pupil Cost (ALL-IN). This ALL-IN cost includes the full amount of warrant articles expensed each year, or the annual amortization of principal and interest for warrant articles covering a number of years. For example, the 2013-2014 CPP for SCSD was \$19,012 and the ALL-IN Per Pupil Cost was \$21,538. For ASD the 2013-2014 CPP was \$17,480 and the ALL-IN Per Pupil Cost was \$19,310.

In summary, there are two cost methods for capturing data: (1) CPP, which includes only the operating expenses divided by the student population based on ADM-A and (2) ALL-IN Total Actual Per Pupil Cost, which is the total annual actual cost, including warrant articles divided by the same student ADM-A population. When comparing per pupil costs, one or the other cost method must be used exclusively to avoid the Apples to Oranges issue addressed in comment #1.

COMMENT #5: "Aging buildings and physical plant are the cause of large differences in CPP."

False - Although Operational Costs of the physical buildings are a component of CPP, the major costs included in this category are the Salary and Benefits of the Maintenance Personnel and utilities, such as fuel and electricity. Repairs and minor building renovations are included in this cost, but do not have a major effect on the CPP calculation, because large repairs and renovations are normally handled through warrant articles that are completely removed from the CPP calculation. For example, the Roof and HVAC renovations at Souhegan High School were handled through warrant articles. Since these major expenditures are not part of CPP, they do not affect CPP community-wide district comparisons. These major repairs and renovations are included in the ALL-IN Cost and the annual cost of these major repair/renovation items is substantially affected by the number

of years used to amortize these costs.

COMMENT #6: "The Amherst Taxpayer is not bearing 100% of the costs, because Mont Vernon contributes a portion to our schools, so total CPP must be reduced for Mont Vernon's portion of the costs."

False - CPP is a standardized metric used to calculate and compare the costs of school districts. Although there is cost sharing with Mont Vernon through tuition reimbursement in ASD and tax appropriation in SCSD, the CPP comparison with other districts is valid no matter who is paying the bill. Amherst and Mont Vernon taxpayers are both concerned about the costs related to educating our students and the cost allocation between the two towns has no bearing on the NH DOE CPP metric.

Summary Highlights:

- There are two methods to compare costs in school districts: CPP (Cost Per Pupil) Operating Expenses and ALL-IN Total Actual Per Pupil Cost.
- CPP is a valid method to compare day-to-day operations between school districts. The formula for this calculation is standardized by the NH Department of Education and excludes items that may distort compari
- High School CPP comparisons are completely valid, because all NH high schools include the same grade range.
- Elementary and Middle School CPP are close approximations of actual costs even though the grade ranges may differ.
- ALL-IN Total Actual Per Pupil Cost is the Annual Actuals for the year divided by the number of students served using ADM-A and includes the amortized cost of major warrant articles.
- Comparing CPP by district or ALL-IN Cost by district are both valid and fair comparisons. However, comparing one district's CPP to another district's ALL-IN Cost is not a valid comparison.
- Cost sharing between Amherst and Mont Vernon does not invalidate the CPP metric, as both communities have a vested interest in our tax dollars being spent wisely.


